
Tips for gathering your HHW for safe disposal

- Seal containers tightly.
- Containers must be labeled.
- Bring items in their original containers inside a sturdy box.
- If original container is leaking or damaged, transfer product to a safe container and re-label.
- Don't mix products together.
- Be prepared to leave your containers.



Think Before You Buy

- Let the signal words, flammable, toxic, corrosive and explosive/reactive serve as an awareness guide.
- Buy the least hazardous product, search for safer alternatives and look for childproof packaging.
- Buy only as much of a hazardous product as you presently need and resist the economy size.

Finding Safer Product Choices

Descriptions such as "non-toxic" or "environmentally friendly" don't mean they are safe for humans, pets or the earth.





Products with the Safer Choice label help consumers identify and select products with safer chemical ingredients, without sacrificing quality or performance.

Penny-Wise & Non-Toxic Alternatives

All-purpose cleaner: Baking soda - dissolve 4 tablespoons baking soda in 1 quart warm water for a cleaning solution or use baking soda sprinkled on a damp sponge.

Metal cleaner/polish: Toothpaste - to clean tarnish off gold and silver (not silver plate), with a soft toothbrush or cloth. Rinse with warm water and polish dry.

Pests: Boric acid - kills ants and roaches by spreading around entryways. Should not be applied to areas where small children and animals will be in contact.

About the **ORSWMD HHW Program**


